economical, cultural relevance etc. has to be invariably kept in mind. In order to meet the above objective to a greater extent, certain methodology has been suggested as below:-

- a. The subject expert nominated shall prepare a draft syllabus of his/her area(s) of study. While doing so, he/she shall consult the syllabi of his/her and other reputed universities in order to have broader consultation. Detailed proforma is enclosed which has to be submitted along with draft syllabus (both hard and soft copy). TA/DA and Honorarium as per UGC TA/DA norms will be paid, for the final meeting.
- b. Each subject expert shall interact with other experts of the team as well as subject experts of other universities, while preparing the draft syllabus through e-mail, website, etc.

Further, at present, there are number of ongoing Major Research Projects in the area of Humanities & Social Sciences which are due for Mid-term evaluation.

In addition, UGC has also received a large number of fresh research proposals from University and College teachers for financial support in different areas of Humanities and social sciences. In order to evaluate these fresh research proposals as well as the Mid-term review of the ongoing projects, a Committee has been constituted.

In regard to the above, it may be noted that you have been nominated as one of the member of Expert Committee in the discipline of Hindi.

The meeting of the above Committee has been fixed on 11/1/2010 at 10.00a.m. in the office of the University Grants Commission, Bahadur Shah Zafar Marg, New Delhi-110 002.
